



Octane Time Attack - Time Attack Event Waiver and Release of Liability

Assumption of Risk:

I understand and acknowledge that participating in a time attack event involves inherent risks, including but not limited to the risk of property damage, personal injury, and death. I voluntarily assume all such risks associated with my participation.

Release and Waiver:

In consideration for being allowed to participate in the time attack event offered by Octane Time Attack, I, on behalf of myself, my heirs, executors, administrators, and assigns, hereby release, waive, and discharge Octane Time Attack, its owners, agents, employees, and team members from any and all claims, liabilities, demands, actions, or causes of action, whether in law or in equity, arising out of or related to any loss, damage, or injury, including but not limited to property damage, personal injury, or death, that may be sustained by me or to any property belonging to me during the course of participating in the time attack event.

Exclusion of Liability for Damage:

I understand and acknowledge that Octane Time Attack and its team members are not responsible or liable for any damage to my car, the racetrack, or any other property, even when the event involves coaches driving the cars. I agree to hold Octane Time Attack harmless for any such damage.

Client's Responsibility for Damage:

I acknowledge and agree that I am solely responsible for any damage caused to the cars, racetrack, or other personnel during the time attack event. I understand that I will be responsible for covering any costs associated with such damages.

Insurance:

I acknowledge that it is my responsibility to obtain and maintain appropriate insurance coverage for my car and personal well-being. I understand that Octane Time Attack does not provide insurance coverage for my property or person.

Compliance with Instructions:

I agree to comply with all instructions, rules, and guidelines provided by Octane Time Attack and its coaching staff during the time attack event.



Indemnification:

I agree to indemnify, defend, and hold harmless Octane Time Attack, its owners, agents, employees, and team members from and against any and all claims, suits, actions, liabilities, costs, and expenses, including attorneys' fees, arising out of or in connection with my participation in the time attack event.

Governing Law:

This Waiver shall be governed by and construed in accordance with the laws of Texas, and any legal action or proceeding arising out of or related to this Waiver shall be brought exclusively in the state or federal courts located within Hays, Texas.
